# **Old Business**

# State of Idaho Annual Report

This is on-going report that must be completed at the end of each year. It is with the Secretary of State's office, Idaho. Our organization, Pack Llama Trail Association, "entity status" is of good standing. File # 0000389028. Old file # C127071. The registered agent on file is listed as Dick Sheehan, one of the founding members of the PLTA. Since Dick has retired from PLTA administration would it be more appropriate to change the agent to president Tom Seifert.

#### **Discussion Points**

- It is not difficult to make the change.
- The purpose of the agent is to be the target of any suite that may be leveled against the PLTA
- If we change to Tom's name, should we then determine that whoever the current president is, they should be the organization's agent. If so, we should update the Standing Rules accordingly.
- Does Dick Sheehan support this change?

#### **Action Taken:**

Tom will contact Dick and explore how he feels about the situation and what he recommends.

#### Trial on Request Proposal

The Pack Trial Governance Committee responses have been arranged into a letter that was sent to Board members for review. (November 20, 2019) This letter, referred to as, 'Working Proposal for the Board: Setting parameters for Pack Trial on Request – has been placed on the Groups.io site for Board collaboration. Board members were asked to add their improvements, and or questions by December 3, 2019. It was intended that Board suggestions would be placed into final draft to be voted on during the December 17 Board meeting.

#### **Discussion Points:**

- The proposal is useful and well defined, however its applicability is limited since we have so few certifiers and organizations hosting trials.
- Only Burns Llama Trailblazers (BLT) and Southern States Llama Association (SSLA) are consistently hosting
  trials. SSLA has many hoops to jump through in order to use the courses they set up at Dupont State
  Recreational Forest. Those courses are not readily accessible. BLT has courses set and can use them any
  time. They hold a year-long sanction for trials, so they can set up a trial for anyone requesting them at any
  time (given that administrative timelines are met), so they do not need the proposal to act in accordance
  with it.
- What is truly needed is more certifiers. Until we have those, the proposal has limited value.

#### **Action Taken:**

Members present unanimously agreed to finish writing a refined and complete version of the proposal, and to hold that version until such time the presence of adequate certifiers makes it appropriate to implement it. Persons responsible for finalizing a document were not identified, nor was a timeline set for doing so.

#### Groups. io

With the demise of Yahoo Groups, the Board has been exploring the use of Groups.io as an alternative. A private group site for board members has been set up and board members have been testing it. Scott Noga and Greg Hall have agreed to administer the site

#### Discussion:

- Board members have found the free version of the site useful
- Files held on the Board's Yahoo Group site have been backed up. Arrangements need to be made to transfer them to the Groups.io site.
- Mileage Club is in great need of a group site being set up for them. The certifiers and the Governance .
   also need sites.

#### **Actions Taken:**

- The Board accepts the free version of Groups.io as their new platform for electronic communication
- Greg Hall will set up group sites for Mileage and for others.

## **New Business**

# Request to Extend Timeline for Pack Trial Handbook Update:

Secretary Lisa Wolf requested that the timeline for the next revision of the Pack Trial handbook be extended to the end of February.

#### **Discussion:**

Lisa is working on several critical projects and has been putting in a lot of time. She was cordially recognized and thanked for her efforts by all members present.

#### **Action Taken:**

Lisa's request was unanimously granted.

# **Pack Trial Certificates**

Tom Seifert provides certificates to owners of llamas successfully qualifying at each pack trial level. Doing so is often held up by lack of appropriate images to use on the certificates. Tom is anxious to provide certificates in a timely manner. He asked the Board: Should a time limit be set on getting me pictures for certificates? At a certain point, (one month, two months – should we build the certificate without a picture and send it to those who have a certified llama?

#### Discussion:

- Concern was expressed that trials are complicated, require too many fees, and require too much paperwork; that they are not fun.
- It was pointed out that this issue was addressed in the fall of 2017. Section 8.2 Pack Trial Certificates of the Pack Trial Handbook was read and discussed. This section clearly explains the process the Board agreed upon to handle the issue.
- Further discussion focused on content of the database, the possibility of automatically generating certificates, the need for so much paperwork, and the reasons the Board chose to implement the current policy.
- Tom also explained the difference and purposes of the "Certificate of Completion" which is received at the successful completion of each trial, and the certificate a llama receives upon earning a title after completing all the necessary trials for a given level

# <u>Proposal to reduce the insurance risk of businesses involving the use of llamas.docx</u> Content:

Proposal to reduce the insurance risk of businesses involving the use of llamas.

The purpose of this letter is to request consideration of a reduction in liability insurance rates for businesses that certify their working llamas via the Pack Llama Trial Association, Inc. (PLTA), an organization that certifies working llamas have been independently evaluated for safe behavior irrespective of handler and in realistic settings.

Businesses exist that involve the use of llamas, ranging from interactive "safari" through day "picnic" hikes to full service outfitter and llama rental services. Unavoidably the interaction between animals and people involves some level of risk, due to the unpredictability of conditions and actions of both animals and people. Hence, the need for liability insurance for the conduct of such businesses.

The PLTA was formed the beginning of 1998 as a non-profit organization to preserve and promote working llamas while educating the public in the humane and safe use of llamas as packing companions. To further this goal, the organization established the PLTA Pack Trial, a means of testing pack llamas against a written standard that allows evaluation and recognition of a llama's ability to perform in realistic conditions. Four levels of ability are recognized, Basic, Advanced, Master and Elite. Llamas earning certification as PLTA packers have demonstrated true packing skill and performance ability. The PLTA is the only organization in the world with a working llama certification program based on a written standard.

More importantly from a liability standpoint, the trial evaluations at each level include strict safety and manageability standards. These tests begin with the llama having a halter removed

and then put back on, loaded and unloaded from a trailer or vehicle, negotiating a picket line for five minutes, being properly saddled, and having the panniers (packs) suitably attached, all without difficult or unsafe behavior exhibited. During the conduct of each trial, any behavior that places the handler at risk such as jumping and bumping into the handler are penalized and can disqualify the llama. A llama must pass multiple consecutive trials to receive certification at a given level.

The employment of certified llamas in the conduct of business would provide the insurance provider assurance that the llamas are low risk of initiating or amplifying undesirable behavior that could lead to injury and potential liability claims. The PLTA would like to know if a provision could be established to offer clients a discount option for the use of certified llamas, not only for the benefit of the client and insurer to reduce risk, but to enhance the attractiveness of the provider product to the client over that offered by the competition. # <u>Parameters for Pack Trial on Request 11-20-19.docx</u> Content:

November 20, 2019

Working Proposal for Board: Setting parameters for Pack Trial on Request

#### Pack Trial on Request proposal 190711.docx

This proposal, would add open scheduling for pack trials outside of regular events. It would facilitate members who have scheduling conflicts that preclude attendance at an officially sanctioned pack trial event. This will allow them to use a certified course at their request and the convenience of a supporting steward or certifier. PLTA membership, registered llamas, and all paperwork for certification would be required. Under this proposal, field courses would only be held on a re-certified course with appropriate mileage, appropriate elevation gain, and qualified obstacles. If an owner is unable to attend an event, this proposal would allow them to undertake a personal trial under the scrutiny of a steward or certifier who would conduct the trial in the same manner as one held at a regular event. Upon completion, paperwork and fees would be turned in to the appropriate board members.

### Specific parameters:

- 1. This proposal will be agreeable to all levels. (Basic through Elite)
- 2. The "Pack Trial on Request" proposal may only be used at 50% of any level trials. (example: Basic, 2 trials one on request; Advanced, 3 or 4 trials, of which only 2 could be "trial on request.")

- 3. A minimum of one trial per level must be completed in a group trial event.
- 4. All courses must be pre-certified, from a previous trial(s).
- 5. If a course has been set by a group, (such as BLT or SSLA) they will be considered the 'trial host."
- 6. The 'trial host' will be responsible for getting all paperwork to the appropriate board members and having a map of trial courses to be used by the llama owner/handler.
- 7. However, it will the responsibility of the 'user' to provide for an emergency medical situation.
- 8. If a handler/llama owner is a member of the SSLA and wishes to use the pre-certified course, since the SSLA has previously paid annual sanctioning fees, there will be no required extra fees.
- 9. If a handler/llama owner would choose to cover miscellaneous expenses of the steward or certifier, such as travel money, or providing lunch, that would be acceptable.
- 10. A 'certifier' must be apprised of the trial and be on call, to answer any questions that might arise.
- 11. If a certifier is unable to answer a question or issue, it will be referred to the Pack Trial Governance committee, for their input.
- 12. Trust will be the key phrase. It is the board's hope all stewards and certifiers will use best common-sense judgments for any and all trials.

Board members: Have at it with your suggestions, questions, improvements.

Please send all of your improvements to me before Tuesday, December 3, 2019

I would like to have a final draft out to you several days prior to our meeting for your approval.

For our December 17, 2019 Board meeting, it would be nice to vote on this proposal.
