Announcements and Information:

- 1. At this time, a current PLTA member is working on a "Trial in a Box" that may help future host/certifiers in putting on a Trial.
- 2. Discussion has begun on the idea that a Trial may be held at any time of the year, ir-regardless of a sanctioned/publicized event. How this would occur, a member, on a sanctioned and certified course, could use a steward and work their llama through a course for certification. This would help those members who were unable to attend a specific (dated)Trial. Sanctioning fees would still have to be paid, but sanctioning fees are good for an entire year.
