New Business

Issue: New Board members.

<u>Discussion:</u> Thomas Rachiele, Kameron Gordon, and Becky Cunningham have requested membership on the Board of Directors. All are members in good standing and fully qualified to assume positions. Becky is willing to take on the presidency for the short term.

Motion: I move to accept Becky Cunningham as a member of the board of directors.

Vote to Accept or Deny: The motion was accepted unanimously.

Motion: I move to accept Thomas Rachiele as a member of the board of directors.

Vote to Accept or Deny: The motion was accepted unanimously.

Motion: I move to accept Kameron Gordon as a member of the board of directors.

Vote to Accept or Deny: The motion was accepted unanimously.

Issue: Jen hood is resigning from her position on the board.

<u>Discussion:</u> Jen is willing to allow the organization to continue to use her address as the official PLTA office site so that we can continue being registered in Idaho.

"I need to remove PLTA from my plate. I know you are concerned about the corporation staying in Idaho, so I am fine with my address being used, if someone outside of Idaho takes the tasks over. I can forward any mail that comes to me. I will scan and email paperwork to get it to whomever quicker and then forward it via USPS (at my cost.) I have no problem doing that to help the organization. Until you find someone, I will continue to complete the duties, but won't be a part of the phone conferences."

- It was noted that the candidate to replace Jen is not required to own llamas
- Greg will look into the possibility of having his wife 'volunteer' for the position

<u>Motion:</u> I move to accept Jen Hood's resignation from the board while retaining her services as treasurer until we can find a replacement -- Greg Hall, seconded by Laura Steere

Vote to Accept or Deny: The motion was carried unanimously.

Issue: New president

<u>Discussion:</u> We currently are operating without a president due to Tom Seifert's passing and Vice President John Fant is ill and unable to move into the position. Becky Cunningham is willing to take the president's role for the short term. She has extensive experience running non-profits, writing grants, holding pack trails for over twenty years, running a llama breeding program, participating in llama shows, herding 4H kids for thirty years or so, and dealing with all things llama. She is exceptionally qualified for the position.

Issue: Secretary Duties

<u>Discussion</u>: Lisa can no longer carry out all the duties she has been assigned. She has been responsible for writer/editor, website, database, and secretarial duties. These need to be apportioned out and assigned in such a way that she is left only what she can handle. She prefers to retain only database management. She has been on the board for most of the last ten years and is worn out. Her term officially ended last June. We need to find a new secretary.

Issue: Using Zoom for future meetings.

 - reduces talking over each other
 - builds cohesion in the group
 - provides more productive engagement
 - allows better relationship building
 - can be used with phone only

Zoom negatives

- requires better technology
- not workable for all people
- free version allows only 40 minutes our meetings have typically run longer

Discussion regarding changing the time and date to better accommodate people in the eastern time zone. Opinion floated that board should be able to be expeditious enough if meetings are held monthly to complete them in 40 minutes.

Laura Greg will do a Zoom test run at home. Lisa will contact members to let them know.

Motion: I move to change the meeting time to Monday and 5:30pm PST (Laura)

Amendment to motion: Motion amended to 'if the other members can manage it'. (Lisa)

Vote to Accept or Deny: The motion was accepted unanimously

Issue: ILR coordination

<u>Discussion:</u> Kyle Mumford is our new ILR contact. He has requested that we supply PLTA updates to the ILR newsletter. We need to designate someone to take on this responsibility. Also, Tom was working with the ILR board to get PLTA credentials listed on the Ilamas' pedigrees. We thought this was accomplished but it is not showing up on the ILR website. We need someone to pursue this.

<u>Action to be taken:</u> Lisa will negotiate with Becky to take on working with the ILR to get certification included on pedigrees.

Issue: SSLA Spring Pack Trail

Discussion:

- 1) Lisa contacted Mary Rose Colins, pack trial coordinator, to assure her that the PLTA is still functioning and explain where she can send her sanctioning paperwork and payment.
- 2) Greg, noted that the Dupont State Forest Recreation Area in North Carolina where SSLA normally holds trials may be closed due to COVID19. He explored nearby Elderberry Llama Farm as an alternative and found it even more suitable in many ways. It has plenty of miles, elevation, and appropriate obstacles available on ATV-free trails for Basic and Advanced trials. It would also give SSLA an opportunity to switch out their event to new territory.

Action to be Taken: Greg will negotiate with SSLA to hold a trial there in the fall.
