Please, do some homework before purchasing stock. One of the roles of the PLTA that I would like to emphasize is that the PLTA's prime objective is to discover and recognize llamas that can fulfill the llama packer's needs on the trail by performing in a manner consistent with the demands of actual packing conditions. PLTA trial events for those who have never attended one, are designed to test the llama in negotiating obstacles found in the back-country. The Trial and Challenge events are meant to build skills, provide education, and build comradery among llama and alpaca owners. Owners and llamas can progress from a Basic Skill set, through Advanced, Master and finally Elite, if they so choose. Pack Llama Trail
